

RE: Schedule E negative entries on April 15 Quarterly Report covering period 1.1.98-3.31.98 and dated 12.1.98

Date: December 1, 1998

As per letters from the FEC dated May 20 and June 11, 1998, this amended report includes the itemized negative entries from campaign expenditures in 1996. The \$1737.38 of un-itemized expenditures come from 38 checks to individuals who never reached the \$200 yearly aggregate disbursement level. They were not initially itemized, so, as per a phone conversation with Ms. Manzano, they were not itemized here.

Secondly, the negative entries labeled as "Wages (memo-2)" were all initially reported as Wages under Schedule E, so they are entered as negative entries on Schedule E here. We are a grass-roots PAC, and these wages were paid to individuals for going door-to-door to deliver the campaign message to voters. This is the reason these expenditures are entered on Schedule E, instead of Schedule B, which wages normally fall under.

Thirdly, the check for the News and Observer entry marked "Ads (memo-3)" was lost in the mail and never cashed. We subsequently paid for the ads placed with another reported disbursement, but we never indicated that this previous check went un-cashed.
