Dear Treasurer:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 2 items:

1. Your amended report discloses additional receipts and totaling \$150,279.70 on Lines 11(a)(i), 11(c), and 17 of the Detailed Summary Page that were not disclosed on your original report. The Commission notes the memo text attached to your report stating, "The original report was filed with incorrect receipt and disbursement data due to a data processing error. This report discloses the correct information." Although the Commission may take further legal action concerning this matter, your clarification and any additional clarification you may have will be taken into consideration. 11-CFR §104.3
2. Your amended report fails to disclose disbursements previously disclosed on your 2010 April Quarterly Report, received 4/16/10. Please be advised that when amending an electronically filed document, you must submit a complete version of the report, rather than just those portions that are being amended. The Commission notes the memo text attached to your report stating, "The original report was filed with incorrect receipt and disbursement data due to a data processing error. This report discloses the correct information." Although the Commission may take further legal action concerning this matter, your clarification and any additional

clarification you may have will be taken into consideration. 11 CFR §104.18(f)

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
