This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Your Committee filed an amendment to the 12 Day Pre-General Report dated October 22, 1998 which included a \$46,585 independent expenditure made on behalf of a federal candidate on October 21, 1998 (pertinent portion attached). However, you have failed to include this amount in your Line 24 total on the Detailed Summary Page of the 30 Day Post-General Report. In addition, it appears that your committee has failed to file the required 24 hour notice for this independent expenditure. Please provide further clarification regarding this discrepancy and amend your report(s) if necessary.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter. 
