The appropriate phone calls and letters are done. Item 2 inadequate identifications are being pursued by phone and letter. Item 3 referencing lack of FEA payroll, there was none in this period. Item 4 referencing print media and mailing are not candidate specific. Item 5 referencing MEMO activity has been addressed and will now appear correctly on the report. This was due to incorrect posting or missed entries. Item 6 now provides the purpose for each disbursement. Item 7 the references to catering were for a general meeting and not candidate specific. Continued efforts are being made to correct the problem we are having in providing H2 Schedules. Thanks for your patience.
