This amendment is being filed in response to your letter dated April 6, 2009, in which you indicate that our committee had failed to file a Pre-General Election Report. This report would have been required because of a contribution to Candice Miller for Congress that was reported as being made on October 10, 2008. After investigation of this issue, we found that the contribution was made on October 20, 2008 and the October 10th date was a typographical error.
