This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. An adequate response must be received at the Commission by the response date noted above. An itemization of the information needed follows:

-In accordance with 11 CFR §102.14(c), "The name of a separate segregated fund...shall include the <u>full name</u> of its connected organization. Such fund may also use a clearly recognized abbreviation or acronym by which the connected organization is commonly known". The Statement of Organization filed by your committee indicates that the name of your connected organization is "Pacific Seafood Processors Association," however, the name of your separate segregated fund is "Pacific Seafood Political Action Committee." Please amend your Statement of Organization to clarify this discrepancy and comply with 11 CFR §102.14(c).

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. Requests for extensions of time in which to respond will not be considered. Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.
