Dear Mr. Tarzi:

I am writing to you in response to your Request for Additional Information (RAFI) to Keeping America Competitive PAC (C00514919) dated April 12, 2015. The RAFI listed four individuals (Nicole Berman, Ralitzia Dimitrova, Jane Frank, and Stacey Tannenbaum) who appear to have made excessive contributions in 2014. Each of the individuals listed had a contribution for \$5,000 dated 2/11/14 which was a reattribution from a larger contribution (Bernard Berman, Ivelin Dimitrov, Alexander Frank, and Leonard Tannenbaum, respectively). These contributions were actually received at the end of 2013 and should have been reported in that year. While the original contributions were given the correct dates (at the end of the 2013 report), we erred in not reflecting these four reattributions in the 2013 report. Our intent was to reflect them in 2013, but this did not come through due to some difficulties using the FECFile software. We have filed amendments to correctly reflect those four contributions in 2013 rather than 2014. Thus, none of those four individuals is currently over the \$5,000 limit for 2013 or 2014.

However, in going through these steps, we noticed an excessive contribution that was not mentioned in the RAFI. Keeping America Competitive accepted \$6,000 from James Velgot in 2013. Immediately upon discovery of this, we refunded \$1,000 to Mr. Velgot. Please find a copy of that check attached. That refunded contribution will be reported on our next periodic FEC filing, but we wanted to proactively make you aware of it beforehand.

We hope that these actions remedy the issues mentioned in the RAFI. Please feel free to let us know if you have follow up questions regarding either the four reattributions or the \$1,000 refund.

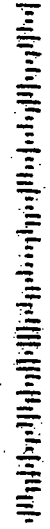
