This amendment corrects Mike O'Malley's aggregate 2017 contribution total as of the close of this reporting period. As explained in prior amendments (1) a \$2,000 refund was issued in January for an excessive 2016 contribution, (2) Mike O'Malley made a \$5,000 contribution in July, (3) a 'Michael' O'Malley made a \$5,000 contribution in August, (4) it was confirmed in November that Mike and Michael are the same person, and (5) another refund for \$5,000 was issued to the contributor in November. However, at the close of the September Monthly Report, our software should have disclosed \$8,000 as his aggregate total:  $(-\$2,000 + \$5,000 + \$5,000 = \$8,000)$ , not \$5,000 as disclosed on the original September Monthly Report.
