Dear Mr. Weidman:

In accordance with 11CFR 104.3(a)(4)(i) of the Federal Election Commission regulations, I submit the following clarification of the process used by The National PAC, Inc. to obtain the occupation and employer information of any person who has contributed in excess of \$200 in the aggregate during the calendar year.

Anyone contributing in excess of \$200 in the aggregate during the calendar year, and who does not provide information as to their occupation and/or employer is automatically sent a form letter from The National PAC, Inc. as attached. (SEE: Letter A) Said letter requests that the contributor provide this information as required by the Federal Election Commission. This process is and will continue to be the standard operating procedure of The National PAC, Inc.

If NatPAC does not receive an answer to the written request mentioned above within the calendar year when it was sent, a second letter is mailed to the contributor. Enclosed is a copy of this form letter for your records. (SEE: Letter B)

When NatPAC receives a response to these letters the information is transmitted to the Federal Election Commission through a separate letter listing the contributor's name, address, occupation and employer as well as the FEC report where the contributor was originally recorded. A copy of this letter is also enclosed for your records. (SEE: Letter C)




