Concerning the identification of each contributor we do indeed make at least one effort per solicitation to identify the occupation and place of business of each contributor. The following statement is included with every solicitation letter we send out:

Corporate contributions cannot be accepted. Contributions to Justice PAC are not tax deductible. Federal Law requires us to ask you:

Concerning your second point regarding administrative expenses we do not maintain an office or any employees. Therefore, we have no expenses such as rent, utilities, salaries, telephone service, or office equipment.

The address listed above is used only as a legal address to receive mail.

We do, of course, have some incidental expenses for postage and office supplies and we do from time to time reimburse phone expenses or pay an independent contractor for clerical services. All payments in these categories are properly reported when they are incurred.
