
Loans Totaling: \$51,500

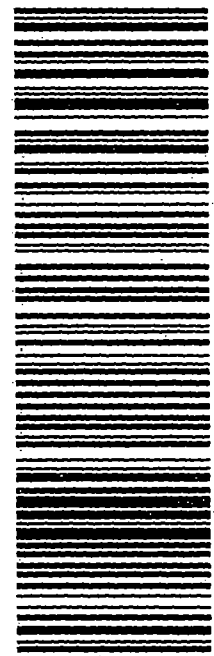
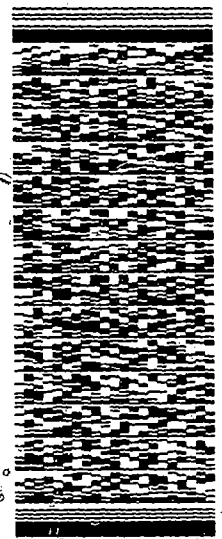

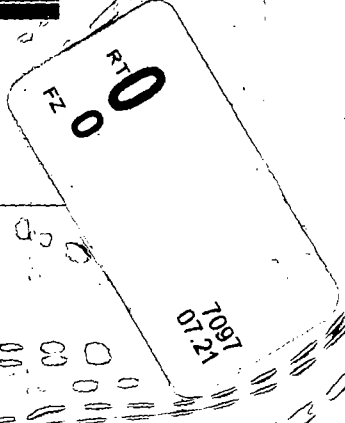
