This letter is in response to the Commission's letter our committee received regarding the above referenced report. Please see below for our complete response.

Our committee is aware of the best efforts standard established by the Commission. We do have a system in place to meet this standard. We include the appropriate disclaimer on all original solicitations informing the donor of the federal requirement for reporting such information. In addition, we make follow up phone calls for the contributions for which we do not receive this information. We maintain a log to record this activity. This follow up also reiterates the requirement by federal law that we are mandated to request this information. To meet the final segment of the standard, please see below for the information that we have obtained since the filing of the original report. It is our desire to make the public record as complete as possible.
