Dear Mr. Gibson,

I received your letter today informing me that we erred in not filing an April Quarterly Report for 1/1/2006 – 3/31/2006. I apologize for not filing this report on behalf of my group, the Torrance Democratic Club. I am relatively new in my position as Treasurer, and have never been through filing deadlines for federal election years. When I visited the FEC website to see if we qualified to file in April, I mistakenly read that our filing was “required only if committee makes contributions or expenditures in connection with election during the reporting period.” I realize now that this applied only to the primary election cycle, and that we are still required to file quarterly even if we did not make any applicable election expenditures.

We are a small club, run entirely by volunteers, and are still figuring out how to be in compliance with all the reporting rules and regulations. As you can see by the filing I have enclosed, we did very little monetarily this past quarter—our income was due solely to 5 people paying their membership dues, and our expenditures were for member communications and bank fees.

Again, I most sincerely apologize for not filing our quarterly report in a timely fashion, and will do my very utmost to make sure that all future filings are at the FEC on time.
