
Dear Ms. Winship:

This responds to your letter dated January 23, 2009, concerning the above referenced FEC report.

1. Schedule A of the report erroneously reported \$46,000 in contributions from Mr. Philip Mundt. The correct amount of the contribution on 9/26/2008 was \$250.00. Due to a computer error between our online payment gateway and our online donor database, the online contribution was replicated 183 times for \$45,750.00. The error was discovered immediately, and corrected before the funds were withdrawn from Mr. Mundt's account. However, the transactions were transmitted to our online database and unfortunately were included in the FEC report. We have amended our October Monthly Report to show the correct contribution of \$250.00 from Mr. Mundt on 9/26/08.
2. With respect to Schedule E, please be advised that all the independent expenditures made by our Committee met the definition of and were properly categorized as independent expenditures.
3. The dissemination date for the media buy from Great American Media was erroneously reported as 8/23/08 due to a typographical error. The correct dissemination date should have read 9/23/08. We have amended our October Monthly Report to reflect the correct 9/23/08 dissemination date.
