This letter is to inform you that as of October 10, 2001, the Commission has not received your response to our request for additional information, dated September 19, 2001. This notice requests information essential to full public disclosure of your federal election campaign finances. To ensure compliance with the provisions of the Federal Election Campaign Act (the Act), please respond to this request (copy enclosed).

An adequate response must be received at the Commission by October 31, 2001. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. **Requests for extensions of time in which to respond will not be considered.** Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.



Dear Mr. Booker:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-On your Amended 30 Day Post-General and Year End Reports you state that the contribution to the Democratic Congressional Campaign Committee "was issued as a federal contribution designated to Non-Federal" and the contributions to Grucci for Congress and Ferguson for Congress were "reported in error these were designated for the Special General Debt retirement for both." However, the amended Schedule B discloses these contributions as a negative entries, indicating that the contributions were not made. Please clarify these discrepancies. Also, please clarify the nature of the contribution to Kelly for Congress. If this contribution was disbursed to this committee please amend your report to show this disbursement as a positive number.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
