This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 2 items:

1. On Schedule H1 of your report, you have used an incorrect method of allocation for administrative expenses, generic voter drive costs and expenses related to public communications referencing any political party committee (but no clearly identified candidates). Separate Segregated Funds and Non-connected committees are required to allocate these expenditures according to a 50% flat minimum federal percentage unless the federal account elects to pay a higher cost. 11 CFR §106.6(c) Please amend your report to provide the proper allocation ratio.

2. On Schedule H2, you have failed to check the ratio type box (i.e., New, Revised, Same as Previously Reported). Please amend your report to correct this omission. 11 CFR §§104.10 and 104.17

- Schedule H4 of your report discloses activity which is 100% federal. For future reporting, please be advised that any activity which is financed entirely by the federal account (including administrative expenses), should be reported on Schedule B supporting Line 21(b).

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the

due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
