

Per FEC RAD a line 21 'other disbursement' adjustment has been made in order to reflect the correct account balance.

Cash adjustment: after a comprehensive legal and accounting review it was determined that a discrepancy of \$1,544.56 existed between the amount of cash in the committee's bank account and the ending cash on hand figure reported in the FEC reports. This discrepancy is thought to exist due to a reporting error in Q32010 that was amended to accurately reflect the debt owed to The Rainmakers. Per FEC RAD a line 21 'other disbursement' adjustment has been made in order to reflect the correct account balance.


