Dear Mr. Maxwell,

Thank you for your letter of June 20th. We have filed an amended report today. The Filing ID is FEC-15727. This supercedes FEC-11636.

On April 5, we discovered that a donor who had given us \$5000 in 2000 also gave a \$300 contribution to us through "American Women Vote 2000" and a \$4750 contribution through "State Party Democratic Victory Fund". We have transferred the excessive \$5050 out of our federal account into a non-federal account.

Attached is a copy of the check we received from the Cuyahoga County Democratic Party and deposited on December 12, 2000. The check clearly indicates it was written on their federal account. I have contacted Cuyahoga County and urged them to file an addendum to their federal report.

I added a memo entry for the unitemized contributions we received from the State Party Democratic Victory Fund.

There was only one exempt activity disbursement. I have corrected the Schedule H2.


The EVENT YEAR-TO-DATE totals should now be correct. I assume these errors are caused by amendments to prior reports filed after subsequent reports.

The "GOTV Ad" expenditure was a generic voter drive activity urging a specific group of people to vote without mentioning specific federal candidates.

The \$211.72 payment to "Fifth Third Bank VISA" should have included a memo entry for "Thrifty Car Rental". I have made the correction on the amended report. All the other credit card disbursements did not exceed the \$200 threshold.
