Please find enclosed the Madison County Democratic Committee's Termination Report. When I spoke yesterday with one of your representatives, I received no guidance on what is required to terminate our political committee's federal account. After I submitted by registered mail on October 20, 2006 my last monthly report covering the period of September 1 to September 30, our political committee has not engaged in financial transactions subject to reporting and disclosure requirements of the federal election law.

As I explained in my letter of September 20, 2006, to my knowledge our committee had never until this year contributed more than \$1,000 to a federal candidate. None of our funds have ever been raised specifically for a designated federal candidate. After the committee decided this September to contribute from its general fund \$2,500 in two installments to our congressional candidate, I was advised to establish a federal account and make the required monthly reports. Frankly, the detailed reporting requirements do not fit our case, but I tried to comply as best as I could.

All the FEC and the public need to know is that the Madison County Democratic Committee contributed \$2,500 from its general fund to Dr. Robert J. Johnson, the Democratic candidate for Congress from New York's 23rd district. Unlike in the case of Dr. Johnson's opponent, that money had not been received from PACs or interested individuals outside the district.
