Public Affairs Support Services, Inc. (PASS) provides assistance to Glaxo Wellcome Inc. with the administration of the Glaxo Wellcome Inc. Political Action Committee (the Glaxo Wellcome PAC), FEC ID Number C-00199730.

This letter is in further response to your letter dated April 5, 1995, to Mr. Mitchell C. Kane, Treasurer of the Glaxo Wellcome PAC, concerning two contributions by the Glaxo Wellcome PAC, one in the amount of \$1,000 to the Friends of Newt Gingrich Committee dated December 16, 1994, and the other, in the amount of \$500, to the Schaefer to Congress Committee dated December 19, 1994. Both contributions were disclosed on the Glaxo Wellcome PAC's 1994 Year End Report (11/29/94-12/31/94).

As you know from my letter dated April 18, 1995, on behalf of the Glaxo Wellcome PAC, we were in the process of determining whether, at the time these contributions were made, the Gingrich and the Schaefer Committees had debts in connection with their respective general election campaigns. If a Committee advised us that it had a debt as of the date of the Glaxo Wellcome PAC's respective contribution, we were going to request confirmation in writing and provide this to the Commission at once.


If there was not a debt to be retired in connection with a Committee's 1994 general election campaign at the time the contribution was made, then the Glaxo Wellcome PAC was going to immediately notify that Committee, in writing, of the Glaxo Wellcome PAC's redesignation of the contribution as a contribution to be attributed to the candidate's 1996 primary election campaign. This redesignation was then to be reported to the Commission as required on the Glaxo Wellcome PAC's report covering the period during which the redesignation was made.

However, in the course of pursuing this plan of action, the Glaxo Wellcome PAC discovered that a total of 7 checks, including the Gingrich and Schaefer contributions, had in fact not been delivered to the intended recipients. Accordingly, these contributions, including the Gingrich and Schaefer checks, have been voided, and are so reported on pages 16 and 31 of the 35-page Schedule B for Line 23 accompanying the Glaxo Wellcome PAC's July 31 Mid Year Report.

I trust that this disposition will now have fully settled this matter to the Commission's satisfaction, and that this letter can be considered as a final response to your initial correspondence.
