Recently, we reviewed our PAC records and discovered the PAC's bank account balance was greater than the PAC's reported Cash on Hand. We determined that discrepancy was largely related to disbursed checks that had not been cashed by campaigns and, with records available, we were able to reconcile the Cash on Hand to the bank account down to \$7,054.10. We created a one-time adjustment entry on 9/30/2012 to reflect the reconciled bank balance.
