In our previous report (January 31 Year End) our cash on hand at end for reporting period was recorded as \$2,813.65. According to our bank, our actual cash on hand at end of the reporting period was \$2,952.65. That amounts to a discrepancy of \$139. Here's what accounts for this discrepancy: 1) the \$94 check written to GVO on 10/24/06 (recorded in Disbursements) has yet to be cashed;; THIS WAS ALSO NOTED ON OUR 30 DAY POST-GENERAL REPORT. SAME ISSUE AS BEFORE. 2) there is \$35 in Income (Receipts) that we can't account for. That is, we must've received a \$35 check that somehow didn't get recorded in our tracking system but which ended up in our bank account. THIS WAS ALSO RECORDED ON OUR 30 DAY POST GEN REPORT. 3) Last, there's a new \$10 contribution that we can not account for. So, $\$94 + \$35 + \$10 = \139 . As advised by FEC staff Dan Buckley, in order to reconcile this report with our cash on hand, we've included a \$139 Cash Correction in this report (July 31 Mid Year) so that the closing cash balance in this report is now \$2,872.95, which matches exactly our cash on hand.
