- 3. Type of communication, Class of communication, Name of the candidate, Date of the expenditure, and the Cost of each expenditure


This information is shown under the heading Summary of Communication Costs. Using the first page of the October Quarterly Report as an example, the information is reported as follows.

Using the above-mentioned report as an example, under Wally Herge's name is CA - 2, which shows that the candidate is running for House district 2 in the state of California. Under J.D. Hayworth's name is AZ - 6, which shows that the candidate is running for House district 6 in the state of Arizona. Under Randy Forbes' name is VA - 4, which shows that the candidate is running for House district 4 in the state of Virginia. A copy of this example page is enclosed.
