

A. TERMS OF THE INITIAL EXTENSION OF CREDIT AND NATURE OF THE DEBT

This obligation is for services performed and invoiced by a commercial vendor during the late stages of the campaign. These services were solicited by campaign staff but were performed without a contract. The services performed included the preparation and distribution of a campaign mailing, as well as the advance of postage fees, paid by the vendor, on behalf of the campaign. Neither party disputes that the work was performed at the request of campaign staff and is properly invoiced.

The Committee unsuccessfully explored additional fund raising for the purpose of settling this debt.

The creditor invoiced the campaign for the services rendered and followed up with the campaign. During initial discussions with the campaign, the vendor refused to accept less than full compensation and expressed the potential for legal remedies.


