We are in receipt of your letter requesting additional information on the following item:

Question 1. In regard to the \$3,000.00 contribution from Farmers Employee Agent PAC: At the time of receipt, we believed this organization was a Federal PAC and deposited the money accordingly. In a follow-up conversation with this organization, we determined this was not intended to be a federal contribution. Subsequently, we refunded the contribution from our Federal Account, and this will be reflected on our September Monthly Report. Additionally, a copy of this letter as well as a copy of the refund check to Farmers Employee Agent PAC will be sent to you via Certified Mail.

In regard to the \$450.00 contribution from Lincoln County Central Committee. We verified with the Chairman of the County Central Committee that this contribution was made up of individual contributions, and it falls within the limits that they may contribute.

Regarding your observation that financial activity has been reflected on the wrong line of the Schedule L Aggregation Page. Per our telephone conversation with you, we have taken steps to correct this on future filings and are not making changes to those lines at this time.

At this time our Committee believes to be in compliance.
