Dear Ms. Della Rocco:

This letter is in response to your correspondence dated October 16th, 2009. Thank you for bringing to my attention a discrepancy between the beginning cash balance of our Mid-Year 2009 filing and the ending cash balance of our year-end 2008 filing.

Upon investigation, it was discovered that the PAC's previous treasurer was mistakenly reporting only the receipts and expenditures relating to our contributable funds. He was not including the balance, expenses, or interest, pertaining to the PAC's administrative funds. The Mid-Year 2009 report, however, did include all receipts and expenditures, as well as the current balance of administrative funds, resulting in the discrepancy.

In order to rectify this oversight, we are filing amendments to the four quarterly reports that were originally filed in 2008. The mid-year 2009 filing is correct as filed.

Again, thank you for bringing this oversight to my attention. I appreciate the opportunity to clarify and correct the public record. Please do not hesitate to contact me if you have any further questions or concerns.
