If you do share control or financing with other committees or organizations, please list their names, addresses, and relationships on Line 6. 11 CFR §102.2

-Line 5(f) indicates that your committee is not a separate segregated fund. A separate segregated fund is a political committee established, financed, maintained or controlled by a corporation, labor organization, membership organization, cooperative or trade association. If your committee is not a separate segregated fund then you should not indicate a type of connected organization. Please amend your Statement of Organization to clarify this discrepancy.
