

Dear Brandis,

On March 31, 2006 this PAC made a contribution of \$20,000 to the Mississippi Republican Party. \$10,000 of this amount was designated to the State (non-Federal) account and \$10,000 was designated to the Federal Account. Since the \$10,000 designated to the Federal Account exceeded the allowable amount from a multi-candidate PAC, we requested and received a refund for \$5,000 from the Federal account. A copy of the refund check is attached and we will report the refund on the June report.
