- 2. Your report is not acceptable as filed. Each report submitted by an unauthorized political committee under 11 CFR §104 must be on the appropriate FEC form. Please re-submit your report on FEC Form 3X. (11 CFR § 104.2(e)) FEC Form 3X can he downloaded from the **FEC** website https://www.fec.gov/help-candidates-and-committees/forms/, requested through the FEC Faxline at (202) 501-3413.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. Requests for extensions of time in which to respond will not be considered.
