Dear Ms. Natividad:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **An adequate response must be received at the Commission by the response date noted above.** An itemization of the information needed follows:

-Schedule A of your report discloses a total of \$2,400 in disbursements to National Right to Life Committee for "Deposited in Error" and "Cont. Intended for Committee." 2 U.S.C. §441b prohibits a corporation or labor organization from contributing or expending funds for the purpose of influencing any federal election, except that a connected organization may pay for the solicitation and administrative costs of its separate segregated fund.

Please amend your report to clarify the nature of the transaction(s) in question and provide the date of the original deposit in your account. If the funds were deposited in your committee's account in error, the original receipt must also be disclosed on Schedule A supporting the appropriate line of the Detailed Summary Page on an amended report covering the period during which the receipt occurred. Although the Commission may take further legal action concerning this matter, your prompt action will be taken into consideration.

-Schedule E, supporting Line 24 of your report, discloses several independent expenditures on behalf of candidates (see attached) which appear to have been distributed or publicly disseminated after the general election date. Please be advised that if the communication is aired in one reporting period and the payment is made in a later reporting period, the independent expenditure should be reported as a memo entry on Schedule E when the communication is publicly disseminated and on a Schedule D if it is a reportable debt under 11 CFR 104.11. When the payment for the independent expenditure is made, the report should show a payment on Schedule E and the same payment on Schedule D, if applicable.

Please amend your report to provide further clarifying information regarding the independent expenditures disclosed after the general election dates.

-The independent expenditure schedule (Schedule E) should disclose the following information: the name and mailing address of the payee, the purpose of the expenditure, the date of payment, the amount of payment, the name and office sought, state and district (if applicable) of the federal candidate, the calendar year-to-date, per election, for office sought total, the election designation, an indication of whether the candidate was supported or opposed and the signature of the treasurer. Please amend Schedule E by providing the name, office sought, state, and district (if applicable) of the federal candidate. 11 CFR §104.3(b)(3)(vii)

-Schedule E of your report discloses the Calendar Year-To-Date Per Election for Office Sought total for Jim Bunning to be \$43,298.08. However, FEC calculations disclose this amount(s) to be \$43,028.03. Please amend your report to clarify this discrepancy.

-Schedule E of your report discloses the Calendar Year-To-Date Per Election for Office Sought total for Richard Burr to be \$97,102.46. However, FEC calculations disclose this amount(s) to be \$96,956.21. Please amend your report to clarify this discrepancy.

-Schedule E of your report discloses the Calendar Year-To-Date Per Election for Office Sought total for George W. Bush to be \$2,581,131.18. However, FEC calculations disclose this amount(s) to be \$2,561,379.33. Please amend your report to clarify this discrepancy.

-Schedule E of your report discloses the Calendar Year-To-Date Per Election for Office Sought total for Thomas Coburn to be \$66,034.56. However, FEC calculations disclose this amount(s) to be \$65,809.56. Please amend your report to clarify this discrepancy.

-Schedule E of your report discloses the Calendar Year-To-Date Per Election for Office Sought total for John Hostettler to be \$6,612.96. However, FEC calculations disclose this amount(s) to be \$5,487.96. Please amend your report to clarify this discrepancy.

-Schedule E of your report discloses the Calendar Year-To-Date Per Election for Office Sought total for Chris Kobach to be \$21,629.92. However, FEC calculations disclose this amount(s) to be \$19,101.50. Please amend your report to clarify this discrepancy.

-Schedule E of your report discloses the Calendar Year-To-Date Per Election for Office Sought total for Mel Martinez to be \$226,277.17. However, FEC calculations disclose this amount(s) to be \$213,587.17. Please amend your report to clarify this discrepancy.

-Schedule E of your report discloses the Calendar Year-To-Date Per Election for Office Sought total for Steve Pearce to be \$8,120.52. However, FEC calculations disclose this amount(s) to be \$7,744.92. Please amend your report to clarify this discrepancy.

-Independent Expenditure 24 hour notices should disclose the following information: the name and mailing address of the payee, the purpose of the expenditure, the date of payment, the amount of payment, the name and office sought, state and district (if applicable) of the federal candidate, the calendar year-to-date, per election, for office sought total, the election designation, an indication of whether the candidate was supported or opposed and the signature of the treasurer. Please amend your 24 hour notices filed 12/1/04 by providing the name, office sought, state, and district (if applicable) of the federal candidate. 11 CFR §104.3(b)(3)(vii)

Unlike previous election cycles, you will not receive an additional notice from the Commission on this matter. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. **Requests for extensions of time in which to respond will not be considered.** Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended. If you should have any
