Please find attached an updated Statement of Organization for the DuPont Good Government Fund (DGGF). This statement reflects the most current address for our affiliated PAC, the Conoco Employees' Good Government Fund (CEGGF). The 1st quarter filing for the DGGF reported a transfer of \$5,378.50 from the CEGGF. Your letter questions the integrity of transfer which exceeds the \$5,000 limit associated with non affiliated PAC contributions. The affiliate PAC that was reported on the first quarter report did not agree with the address listed on the DGGF's statement of organization on file at the time. As the attachment shows, the address has been update to reflect the current location of the Treasurer for CEGGF, Barry J. Miziolek.

This updated statement of organization should clarify that the \$5,378.50 cash inflow did come from an affiliated PAC and therefore does not exceed contribution limits.
