This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Please provide the totals for Lines 11(a)(iii) and 11(d), Columns A and B, of the Detailed Summary Page.

-Line 23 of the Detailed Summary Page of your report discloses a total of \$5,868 in contributions to federal candidates/committees. The sum of the entries itemized on Schedule B, however, indicates the total to be \$5,368. Please amend your report to clarify the discrepancy.

-Line 11(a)(1) of the Detailed Summary Page discloses a figure for the total amount of itemized contributions from individuals/persons other than political committees. In addition, no supporting schedules have been provided. Please amend your report by itemizing all contributions from individuals/persons, which aggregate greater than \$200 in the calendar year. 11 CFR §104.3(a)(2)

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter. If you need assistance, please feel free to contact me on
