
Dear Mr. Moore:

Please be advised that you should add the "Calendar Year-to-Date" total from your previous report to the current "Total This Period" figure from Column A to derive the correct Column B totals.

-Please provide the total for Line 6(d), Columns A and B of the Summary Page.

-Your calculations for Line 21(c), Column A appear to be incorrect. FEC calculations disclose this amount to be \$0. Please provide the corrected total on the Detailed Summary Page.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
