
Dear Mr. Walker:

Upon receipt of your letter dated May 9, 2001 concerning our Year End Report (11/28/00 - 12/31/00), I reviewed the report and found an omission on the Post Election Report that caused the discrepancies in the Year End Report.

In November 1999, Fund For a Responsible Future Political Action Committee was in the process of upgrading our PAC management software. Due to the conversion, a disbursement of \$1,500.00, federal operating expenditure to the payee: Thomas J. Bilely, Jr., was omitted from the Post Election Report (11/28/00 - 12/31/00). Our old system did not report the disbursement but the new system did add the disbursement in the aggregate numbers. Therefore we are amending both the Post Election Report (10/19/00 - 11/27/00) and the Year End Report (11/28/00 - 12/31/00).
