Our bank, in error, paid two wire transfers out of NCGA funds instead of CornPAC SSF funds. The first was a refund to Debra Gangwish of \$30 reported on the May monthly report, the second was a contribution to Elise for Congress of \$1000 reported on the June monthly report. Both errors were discovered and rectified by CornPAC SSF reimbursing NCGA on July 10. These transactions are listed as memo items on this report. The bank also deposited a check made out to NCGA from Syngenta to the CornPAC SSF account in error on July 6. The error was discovered during our monthly reconciliation, and CornPAC SSF returned the funds to NCGA on 8/13. The refund transaction will appear on the September monthly report.
