A review of our December and Year End Monthly Reports raised questions by the Commission concerning missing employment information for contributors. We refer to a letter sent to the commission dated March 25, 2001 outlining our "best efforts" procedures. That response is applicable to this inquiry as well. A copy of the letter is enclosed and amended reports updating any missing information will be sent electronically.

A review of our Year End Report raised questions about a contribution to a candidate in the 2001 South Carolina Special Election. The state of South Carolina held special elections on October 30, 2001 and December 18, 2001, to fill the House seat left vacant due to the death of Congressman Floyd Spence. We made a contribution to the Joe Wilson for Congress Committee in October and allocated the amount toward the 2001 Special Run Off Election. The contribution in question should have been allocated toward the Special General Election held on December 18, 2001.
