The Committee is in receipt of the Commission's letter dated 10/04/2006, regarding the Amended April Monthly report. The Committee's response is as follows: Item 1 - The transfer in was inadvertently listed as receipts from the DNC. This receipt has been correctly attributed to the Florida Party Victory Fund. The funds received correspond with the memo entries for Q4 2005 and Q1 2006. Item 2 - The invoices were received after the April Monthly report had been filed. They were entered into the reporting software as Payables using the March invoice date and later reported as debt on the May Monthly report. However, when the April Monthly report was amended, the reporting software pulled the debt information from the invoice date and re-allocated the debt to the April Monthly report. Please note that all of these debt items were reported on the May Monthly report submitted on May 20, 2006. Item 3 - The Committee received 2 checks from County Committees for Voter File Access on 2/23/06 - Charlotte County DEC for 305.14 and Indian River County DEC for 226.25. The Committee was concerned that DEC checks were not federally permissible and decided it was best to immediately transfer the funds to its Non Federal account. Item 4. The voided checks disclosed on the report were not re-issued. Item 5 - The transfer of the non federal share, \$16.23, of the Federal Express refund was inadvertently overlooked. This omission has been corrected and the transfer will be reflected on the 2006 PG report which will be submitted on 12/7/06. Item 6 - 1. These individuals are not employees of the Committee.
