This letter is in response to our telephone conversation on February 12, 2009 and to your letter of January 27, 2009 requesting an explanation pertaining to the Amended FEC Form 9, dated 10/10/08, which discloses a substantial increase in the amount of donations from the original report, dated 10/3/08. This increase is due to the transfer of Stock initiated on 10/3/08 after the filing of the original report. Acting on the side of caution, we amended FEC Form 9 to include these figures even though the settlement date and monies did not reach the account until October 8, 2008.

As we discussed to avoid confusion going forward, RightChange.com Inc. will now use the settlement date of any stock transfers for reporting purposes.
