The reports are amended due to an error beginning in September of 2008, that was an under reporting of a disbursement of \$5,000.00.


- This caused our bank account to have \$5,000.00 less than the amount shown in our bank account register.
- Adding to this problem/ error, the treasurer at the time, was unable to retrieve bank statements from the bank, after trying unsuccessfully for over 1 year.
- The error was not found until recently in 2010, when we were able to track down the bank statements and reconcile the account.
- We discovered the overdraft and services charges which we now show as the debt on Schedule D. (The bank honored the check).

- In the interim, we changed banks (Q1 – 2010 Filing) and have received regular monthly statements that we are coordinating with the filings.
- For the next filing- we anticipate that the debt on Schedule D will be paid off.
