Dear Ms. Wilkens:

Dr. Stephen Draper, a contributor to the Democratic Party of Georgia, raised our awareness of the web site named: [www.trav.com/cgi-win/allindiv.exe](http://www.trav.com/cgi-win/allindiv.exe). This web site shows that Dr. Draper contributed federal money to the Democratic Party of Georgia during 1998. He contributed \$10,000 during the first quarter of 1998. His contribution was deposited as follows:

Check No. 430 for \$10,000 was split between our state and federal accounts with \$5000 deposited into each account on 3/2/98. The \$5000 that was deposited into the federal account was disclosed on our April 15 Quarterly Report per Federal Election Commission guidelines.

At Dr. Draper's request, the \$5000 that was deposited into our federal account was transferred to our state account on 11/23/98. According to Federal Election Commission guidelines, this transfer was disclosed on Schedule B line 28a - Refunds of Contributions to an Individual. This Post General Report was filed on 12/3/98.

The web site listed his contribution of \$10,000 as originally being deposited completely into our federal accounts, which is incorrect. According to our records we have received no federal money from Dr. Stephen Draper in 1998.

I am writing to you today because Dr. Draper has conveyed to me his deep concern that because of this error your records show that he has exceeded his federal contribution limit. Respectfully, I ask that you review the data that is used to compile the web site and revise it.
