**1.** Line 7 of your FEC Form 5 filing discloses disbursements made for independent expenditure(s). Your filing also discloses contributions on Line 6, "Total Contributions."

Each person (other than a political committee) who made a contribution(s) to your reporting entity during this reporting period, whose contribution(s) had an aggregate amount in excess of \$200 within the calendar year, must be itemized on Schedule 5-A, including their identification information, date, and amount of such contribution(s). In addition, **memo text** must be used to indicate which of these persons made a contribution in excess of \$200 to your reporting entity for the purpose of furthering any independent expenditure.
