On June 12, 1996, you were notified that a review of the above-referenced report(s) raised questions as to specific contributions and/or expenditures, and the reporting of certain information required by the Federal Election Campaign Act.


Your July 3 and 15, 1996 responses are incomplete because you have not provided all the requested information. For these responses to be considered adequate, the following information is still required.

-Your EVENT YEAR-TO-DATE calculations for Administrative/Voter Drive are incorrect. EVENT YEAR-TO-DATE totals for Administrative/Voter Drive costs are derived by aggregating all disbursements during the calendar year for the whole Administrative/Voter Drive category. Your Amended 12 Day Pre-Primary Report Schedule H4 discloses all disbursements as Administrative/Voter Drive expenses. Therefore, the EVENT YEAR-TO-DATE Administrative/Voter Drive total on the 12 Day Pre-Primary Report should be the same as the Total This Period at the bottom of page 32 of 32, Schedule H4 (\$104,514.19). The Administrative/Voter Drive totals on the 12 Day Pre-Primary (\$104,514.19) plus April Quarterly (\$69,502.18) equals an April Quarterly EVENT YEAR-TO-DATE total of \$174,016.37. Please amend your report to provide the correct total.

If this information is not received by the Commission within fifteen (15) days from the date of this notice, the Commission may choose to initiate audit or legal enforcement action.
