



The term "contribution" includes any gift, subscription, loan, advance, or deposit of money or anything of value made by any person for the purpose of influencing any election for federal office. (2 U.S.C. § 441a(a) and (f); 11 CFR §§ 110.1(b) and 102.13(c))

Please be reminded that all refunds and redesignations must be made within 60 days of receipt of the contribution. To date, one or more of the apparent excessive contributions have not been refunded or redesignated.
