Changes have been made to Clark PAC's 2015 Mid-Year Report Detailed Summary Pages and supporting schedules as follows:

(1) Contribution totals. Total contributions were correctly entered on line 11 (a)(i) and 11 (d) and have now been entered on line 11 (a)(iii) under columns A and B as well.

(2) Operating expenditures. Administrative disbursements have been broken out onto a separate schedule B and entered on lines 21 (b) and (c) and lines 36 and 38 under columns A and B. Adjustments have also been made to line 29 to reflect these changes and a new Schedule B for Other Disbursements replaces the original Schedule B.
