This letter is prompted by the Commission's preliminary review of the report(s) referenced above. 1. The beginning cash balance of this report should equal the ending balance of your 12 Day Pre-General Report (10/1/08 – 10/15/08). Please clarify this discrepancy and amend any subsequent report(s) that may be affected by this correction.
2. Line 21(a) of the Detailed Summary Page should only be used to report the federal and non-federal shares of allocable activities. If your committee has only one account, the total federal operating expenditures (administrative expenses) should be reported on Line 21(b). Please amend your report to confirm the nature of your expenditures and to provide the total on the appropriate line.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**
