Dear Mr. Adamsky:

This letter is in response to your letters dated October 13, 2021 regarding the two reports cited above. Your letters indicated that there were entries on Schedules E of the two reports for which there were not corresponding 24 or 48 hour report filed.

We believe that some of the difficulty in matching the Schedule E items with those on the corresponding 24 or 48 hour reports is caused by the difference between the estimates used to disclose the expenditures initially and the final amounts on Schedule E. Also, in some cases the payees were disclosed as the ultimate vendors rather than the actual payees.

We investigated the entries described in your letters and were able to find the following 24 or 48 hour reports for the corresponding entries on Schedule E. The 24/48 hour report transactions were disclosed as estimates.
