#### **BYLAWS OF**

#### DOUGLASS POLITICAL ACTION COMMITTEE (DPAC)

#### <u>ARTICLE I</u>

## **NAME**

The name of this association shall be DOUGLASS POLITICAL ACTION COMMITTEE (hereinafter referred to as the "Committee").

#### **ARTICLE II**

#### PRINCIPAL OFFICE AND ADDRESS

The principal office of the Committee shall be located in Sherman, Texas and the street address shall be 325 East Forest Avenue, Sherman, TX 75090.

#### **ARTICLE III**

The Committee shall be a voluntary, nonprofit corporation and established as an as an affiliated PAC (separate segregated fund), registered with the Federal Election Commission in accordance with the Federal Election Campaign Act of 1971, as amended (the "FECA"). Its connected organization shall be Douglass Distributing Carriers, Inc.

#### ARTICLE IV

#### **PURPOSES AND POWERS**

Section 1. The purpose of the Committee is to provide the opportunity for individuals interested in the future of the petroleum industry to contribute to the support of worthy candidates for federal, state and local office, regardless of party affiliation, whoo believe, and have

demonstrated their beliefs in, the principles to which the industry is dedicated. To further these purposes, the Committee is empowered to solicit, directly or indirectly, and accept, voluntary personal contributions, and to make expenditures in connection with the attempt to influence the selection, nomination, or election of any individual to any federal office.

Section 2. The Committee, and its officers and subcommittees, shall possess and may exercise all powers and privileges set forth in these Articles or incidental thereto, together with all powers and privileges necessary or convenient to the conduct, promotion, or attainment of the purposes of the Committee or these Articles, so long as the exercise of such powers and privileges is consistent with applicable Federal law.

#### ARTICLE V

#### **PARTICIPATION**

All U.S. citizens are eligible to contribute to the Committee and the Committee is authorized to solicit and accept contributions from any person whose contributions may be lawfully solicited.

#### ARTICLE VI

#### **CONTRIBUTIONS**

- Section 1. All contributions to the Committee shall be voluntary, and no contribution to the Committee shall be solicited or secured by physical force, job discrimination, or financial reprisal, or threat thereof, or as a condition of employment.
- Section 2. Basic policies with respect to the expenditure or distribution of all contributions to the Committee shall be within the sole discretion of the Trustees of the Committee.

Section 3. No contribution shall be accepted, and no expenditure shall be made, by or on behalf of the Committee, at a time when there is a vacancy in the office of Treasurer.

#### ARTICLE VII

#### SEPARATE SEGREGATED FUND

All contributions to the Committee shall be maintained by the Committee as a separate, segregated fund in one or more designated campaign depositories. All expenditures of over \$100 made by the Committee in support of any candidate or political committee shall be made from one of these depositories which is a checking account and from no other source.

#### **ARTICLE VIII**

#### **TRUSTEES**

The governing body of the Committee shall be a Board of Trustees, composed of two (2) members selected by Douglass Distributing Carriers, Inc.

The Trustees are empowered to set basic policies with respect to expenditures to be made by the Committee, and to direct disbursements to specific candidates. The Trustees shall determine the procedures for collection and distribution of funds to the candidates and political committees that the Committee shall support and the amount of all expenditures and disbursements by the Committee.

#### ARTICLE IX

#### **OFFICERS**

Section 1. The officers of the Committee shall be the Chairman and Treasurer.

- Section 2. The Chairman of the Committee shall be elected annually from among their members by the Board of Trustees. The dates of elections and the procedures governing them may be determined by the Trustees. The Treasurer will be designated by the President of Douglass Distributing Carriers, Inc.
- Section 3. Subject to the determination of the Board of Trustees, the Chairman shall administer and have general and active management and supervision of all the affairs of the Committee. The chairman shall preside at all Committee meetings and meetings of the Board.
- Section 4. The Treasurer shall be the chief financial officer of the Committee, shall keep the financial and other records of the Committee, and shall comply with all applicable requirements established by law, and shall perform such other duties as may be assigned to him by the Chairman or the Board of Trustees.

## **ARTICLE X**

#### **REMOVAL**

A Trustee may be removed by the unanimous vote of the other Trustees or by the President of Douglass Distributing Carriers, Inc.

#### ARTICLE XI

#### <u>AMENDMENTS</u>

Section 1. These Bylaws may be amended from time to time by the majority vote of the Trustees.

#### ARTICLE XII

#### **DISSOLUTION**

The Committee may be dissolved at any time by the majority vote of the Trustees. In the event of such a dissolution, all funds contained in the Committee's campaign depositories shall be disbursed to such candidates and political committees as the Trustees shall determine.
