If the committee is new and has not previously filed a report, the first report must cover all activity that occurred before the committee registered.

²Reports sent by registered or certified mail must be postmarked by the mailing date; otherwise, they must be received by the filing date.

³Committees that made general election contributions or expenditures before October 1 and did not previously report them must also follow Chart II.
