Dear Mr. Averett:

This responds to your letters of August 9, 2000 and August 11, 2000 regarding the above referenced reports.

Administrative Expenses

The Committee has incurred only *de minimis* administrative expenses in connection with its operation. The Committee's activities have been limited to a one-time solicitation of the partners of Brown & Wood LLP, six (6) contributions to Federal candidates and the preparation of three (3) Quarterly Reports. Services for these activities have been provided by three individuals on a voluntary basis. The cost of the paper used, phone calls and faxes between our New York and Washington, DC offices is *de minimis*, records of which generally are not maintained. No offices have been assigned the Committee; therefore, no rent or utilities can be attributed to its activities.

Multi-Candidate Status

I am transmitting herewith an executed FEC Form 1M which certifies that the Committee achieved multi-candidate status on June 9, 2000. As we discussed by phone yesterday, prior to delivering the contribution to the Lazio for Senate Committee, I spoke with a member of the

FEC's Public Information Office. I advised her that the Committee has been organized for more than 6 months, has received contributions from more than 50 persons and has made five (5) contributions. She advised me that no additional filing was required prior to our making a subsequent contribution of more than \$1,000. Accordingly, I would be grateful if you would accept our FEC Form 1M, effective June 9, 2000 and waive the request in your August 9, 2000 letter that we request a refund from the Lazio for Senate Committee.

I also noted in reviewing the Schedule B to the July Quarterly Report that the date of the Lazio contribution was incorrectly reported. The contribution actually was made on June 23, 2000. The Amended Schedule B referenced below has been revised to reflect that date. In addition, I have enclosed a copy of the check and the Committee's bank statement which shows that the check cleared on July 10, 2000.
