
Pursuant to your letter dated March 14, 2008, received March 18, 2008, it is my understanding that Associated Equipment Distributors Political Action Committee's (AED PAC) Year End Report lacked certain occupational and employer information for a number of individuals that contributed to the Committee between July 1, 2007 and December 31, 2007.

In response to your request for additional information, an amended 2007 Year End FEC Report was filed today.

It is the Committee's policy to request contributor information and to inform the contributor of the federal requirements for reporting such information (see 11 CFR § 140.7(b)(1)) and to disclose all identification information who contribute in excess of \$200. (See 11 CFR § 104.3(a)(4)(i)). The error referenced in your letter occurred due to our implementation of new software designed to facilitate the electronic filing process. Procedures have been implemented to ensure the mistake in the 2007 Year End report is not repeated in the future.
